Gogo's inflight connectivity service will begin in the first half of 2018 and the roll-out of the technology is expected to be completed in the first half of 2019.

Gogo's 2Ku technology is installed on more than 350 aircraft today and delivers proven performance of more than 15 Mbps to each passenger device, covering more than 98 percent of all flight hours around the world with 98 percent system availability.

With an open architecture that leverages current and future Ku satellites, 2Ku offers unrivalled adaptability to keep airlines connected now and in the future. The equipment installed on LATAM's aircraft will include Gogo's new, performance boosting modem. The proprietary features of the new modem significantly increase throughput and reliability to and from the aircraft.
